1 in 4 adults in the UK have a hearing loss, yet their needs are often poorly understood and supported in healthcare settings. Accessible care and communication are critical in palliative care, but deaf people are often missed out leading to critical health inequalities. **Dr Natasha Wilcock**, a hospice doctor at Royal Trinity Hospice, founded <u>IDA</u> through her own experience as a deaf patient and doctor. IDA is an organisation aiming to improve the experience and outcomes of deaf people across healthcare settings. Join this session to explore the experiences of deaf people interacting with palliative care services, discuss real-life cases and explore how you can ensure your care is accessible to deaf people.

Building bridges from research to practice: launch of evidence-based tools applied in a multi-centre impact project to improve medication management

Launch of the Getting Palliative Medications Right Toolkit, followed by sharing of supporting evidence, highlighting possibilities to improve medication management systems in practice. Evidence to support the toolkit comes from observing more than 120 hours of everyday practice and informal conversations at home, in hospital and in hospice. We spoke to 83 patients, informal carers, and professionals, mapping out who does what and when.

Description: Increasing numbers of people are living with and dying from multiple long-term conditions. However, people with multiple long-term conditions are less likely to have access to palliative and end of life care services. This session will explore research projects across two institutions, funded by NIHR and the Wellcome Trust, to understand how palliative and end of life care services can identify those with multiple long-term conditions who are approaching the end of life and what services are currently available. Finally, an interactive focus group will be held inviting participants to reflect on what they and their service can do to meet the needs of the growing population of people with multiple long-term conditions.
